# Fort Collins Museum Local History Archive

## Reproduction Terms and Conditions

*Please read carefully before signing the Order Form.*

1. Photograph reproduction fees are charged for **every** photograph order, regardless if the image is for personal or commercial use. Commercial use of images incurs a use fee in addition to reproduction fees.

2. Two complimentary copies of each publication or production in which the photographic copy appears must be given to the Fort Collins Museum Local History Archive. If the product in which the image was used is a posting on an electronic site accessible by the public, the URL shall be forwarded to the Fort Collins Museum Local History Archive staff.

3. Permission is for **one-time use only**, as described on this form, with no other rights. Any subsequent use (including subsequent editions, paperback editions, foreign language editions, etc.) constitutes reuse and must be applied for in writing. An additional fee may be charged for reuse.

4. All photographs must be credited to the Fort Collins Museum.

- a. With printed matter, the image number must be included in the credit line. The credit line must appear with the item or on a credit page, indicating the page number, for each item. Crediting of each individual item is mandatory in all cases.

**Sample:** Fort Collins Museum, #H16723

- b. With films, slide presentations, and video productions, credit must appear with other credits at the beginning or the end of the production. Image numbers may be omitted.
- c. With display or exhibition, please credit each image within the display or exhibition area and include image numbers. Exemption from this requirement must be approved.
- d. Website usage requires a credit line following the format above on the same page as the image.

5. The user may not misrepresent the image(s) used so as to falsify the information they present.

6. The user **may not reproduce** or permit others to reproduce the photographic copy or any facsimile of it, including digital transfer. Additional copies must be purchased from the Fort Collins Museum.

7. In authorizing the publication of a photographic copy, the Fort Collins Museum does not surrender its own right to publish it, or to grant permission to others to do so.

8. All responsibility for possible copyright infringement and invasion of privacy arising from use of reproductions is assumed by the user.

9. Any exceptions or additions to the above conditions will be subject to the curator of the Fort Collins Museum Local History Archive and/or the Fort Collins Museum Director.
